When it comes to protecting your livestock, whether that be a flock of backvard chickens or dairy cows or anything in between, there are a few key steps to take including biosecurity measures and limited traffic on your property and with your animals. As a livestock owner in Wisconsin, registering vour premises with the Wisconsin Livestock Identification Consortium (WLIC) is an important step.

#### What is WLIC?

WLIC is a private, non-profit organization that works to protect animal health and prevent the spread of disease through livestock and premises identification and traceability. Founded in 2001, WLIC serves as a third-party organization to manage premises registration and renewals while working in stride with the Department of Agriculture, Trade and Consumer Protection (DATCP).

#### Do I have to register my premises?

Yes, it is required by law to register any location in Wisconsin with livestock species on it. Following the December 2003 incident of a dairy cow testing positive for Mad Cow disease in Washington State, the Wisconsin

legislature passed a law requiring every livestock owner in the state to register their premises.

#### What livestock should be registered?

The following livestock should be listed on your premises registration by species:

Beef breed Cattle

Dairy breed Cattle

Bison

•South American camelids such as llamas and alpacas

·Captive Cervids such as deer, elk, moose, caribou, reindeer, etc

•Pias

Goats

Sheep

•Chickens – even if it's just one!

 Poultry, Guineas, Captive Gamebirds. Ratites

•Horses (including mules and donkevs)

•Fish and aquaculture if you require a Wisconsin Fish Farm license

#### What information is provided to register or renew my livestock premises?

Registration of livestock premises includes registration of the address where the livestock are held, the types of livestock (bovine, swine, equine, etc), first and last name, a phone number, email address, and a mailing address if different than the livestock

address. WLIC does not record any information regarding the number of animals at any location to protect producer privacy.

All locations where livestock are housed (if not on the same property), even seasonally, are required to be registered. Once a premises ID is assigned, it remains with that location.

#### Is my information ever shared?

Livestock premises registration is protected by Wis. Stat. 95.51 and Administrative Code ATCP 17.03, requiring producer data to remain confidential. As well, WLIC is a private non-profit organization, not a government agency, and cannot disclose premises registration information from public inquiries.

#### How do I register or renew my livestock premises?

It is easy! Simply visit WLIC's website (wiid.org) and select 'Register Your Premises'. Complete the online form and you will receive your premises ID within 1-3 business days. You may also call WLIC at 888-808-1910 (weekdays, 8am-4pm) to renew your premises registration over the phone.

#### When should I renew?

The best time to renew is now through June. All Premises IDs have the same expiration date (7/31/25), and renewing promptly ensures that you receive prompt service, and avoid unnecessary letters and reminder emails. Continued on pg 3


Livestock owners are also encouraged to contact WLIC to update existing registration information in situations at any time of year such as when contact information changes (phone numbers, emails, mailing address), premises ownership changes, species type changes, if the property is sold, or if livestock are no longer on the property. How does renewing my livestock premises help protect against an animal disease outbreak? Registration information is used to guickly communicate with potentially impacted livestock owners as well as provide Wisconsin animal health officials with data on how many livestock premises are within close proximity of an infected premises. Depending on the mobility of the disease, officials may identify zones to limit or stop livestock movement and reduce the risk of spreading the disease.

Without this information, they cannot efficiently respond, allowing an outbreak to spread before containment. History has shown us that an animal disease outbreak can have disastrous effects on farmers, the community and economy. Don't delay - renew your livestock premises registration today! #### Broker Farms: 50 Years of Quality Milk

In 2024, Broker Farms hit a big milestone—50 years of producing top-notch milk. Fred Broker's journey started when he was just a kid on a farm north of Poskin. WI. After his family's farm was sold in 1967, Fred worked on Lyman Erickson's farm during his teenage years. He later earned a Dairy Management certificate from WITC in Rice Lake and attended farm business management night classes for 40 years. Kathy (Erickson), who grew up on a farm south of Rice Lake, met Fred at the Barron County Fair in 1972, and they tied the knot in 1974. Kathy also earned an associate degree in accounting.

From 1974 to 1977, Fred and Kathy rented a 120-acre farm north of Barron, where Fred milked thirty-five cows and Kathy worked in bookkeeping for Barron County Public Health. Kathy also helped out with the fieldwork. In 1977, they bought a 150-acre farm and milked an average of fifty-five cows for the next 25 years while raising their three kids: Julie, Mike, and Sarah.

Fred and Kathy's children have all found ways to stay connected to the farm and contribute:

•Julie and her husband Joe Moenck moved back to Barron County in 2021 after living in the Rochester and Zumbrota, MN, area for 20 years. Julie works remotely for Mayo Clinic, and Joe is the Director of Organizing for the Minnesota Pipe Trade Association. Joe jokes that he's a "third string" milker, and they love spending time with family and enjoying their home on Red Cedar Lake.

•Mike returned to the farm after getting his degree in Dairy Science from UW-River Falls. He married Cindy (Uher) in 2002. Cindy also has a degree from UW-River Falls in AgBusiness/Accounting and works as the Assistant Controller at Rice Lake Weighing Systems. Their two sons, Daniel and Garrett, help out on the farm and are involved in their community. Daniel excelled in FFA, placing in the top sixteen in the nation for creed speaking in 2023, and Garrett is active in basketball, 4-H, and farm activities.

•Sarah and her husband Chuck Fastner live in Pewaukee, WI, with their son Mason. Sarah works for Baker Tilly as a senior manager of Talent Attraction, and Chuck is a Vice President at Direct Supply. They enjoy traveling, chasing Mason, and spending summers on the boat. Mason loves feeding minerals with Uncle Mike and riding tractors, while Chuck provides tech support.

Over the years, the farm has seen several expansions:

•2002: A new free stall barn and manure pit were built, expanding the herd to 120 cows.

•2003: A heifer barn was added.

•2017: The old heifer barn and parlor were replaced, and the free stall barn was expanded to include a new swing-twelve parlor, milkhouse, and transition cow housing. The heifer barn was also expanded.

Today, Broker Farms has 180 cows, with about 160 milking at any given time, producing an average of eightyfive pounds of milk per cow. They now grow crops on approximately 375 acres of owned and rented land, providing all the grain and forage needs for the herd.

The success of the farm relies on several valuable team members.

•Busse's Barron Acres and Halverson Cattle raise all calves from 0-5 months.

•Ciara Williams has been with the farm since 2022 as the assistant herdsperson, managing many milking and cow care duties.

•Ryan Erickson has worked part-time since 2017, milking and assisting with fieldwork when he's not teaching high school students.

•Amber Anderson milks part-time in the summer when she's home from college.

The farm has received many milk quality awards over the years and is recognized by the state for its excellent conditions through annual inspections. T
